

4-MEMBER PACK PURCHASE AGREEMENT

Del Mar Research, LLC owns and operates the CDx3 Notification Service (the "Service") using the Internet domain CDx3Investor.com, and portions of other web sites and pages and web content (collectively, "www.CDx3Investor.com") through which you have accessed this 4-Member Pack Purchase Agreement.

By purchasing one or more 4-Member Pack(s), the Sponsoring Member, as defined below, agrees with the terms of this Purchase Agreement.

The Sponsoring Member

The "Sponsoring Member" of a group is the member who pays the purchase price, as specified on www.CDx3Investor.com, (the "Purchase Price") for the 4-Member Pack on behalf of up to four group members.

Purchase of a 4-Member Pack is subject to the terms and conditions specified within the Group Subscription Agreement and Terms of Use which is available for view and download on the www.CDx3Investor.com web site.

The Sponsoring Member agrees to provide the Group Subscription Agreement and Terms of Use to all members of the group being Covered, as defined below, by this purchase of 4-Member Pack(s).

Coverage of a 4-Member Pack

The Sponsoring Member agrees to purchase the quantity of 4-Member Packs that are needed for the number of members of the group. Each 4-Member Pack extends the terms and conditions of the Group Subscription Agreement and Terms of Use to a maximum of four (4) members of a group that has a valid group subscription to the Service. Members of a group to which such an extension is made are "Covered" by the 4-Member Pack being purchased.

Effective date of a 4-Member Pack

The effective date of a 4-Member Pack will be when (i) the members being Covered by the purchase of a 4-Member Pack have reviewed and agreed to the terms and conditions specified within the Group Subscription Agreement and Terms of Use and (ii) the Purchase Price for the 4-Member Pack for the members being Covered has been paid by the Sponsoring Member using the www.CDx3Investor.com web site.

Expiration date of a 4-Member Pack

The term of a group subscription to the Service is specified within the Group Subscription Agreement and Terms of Use. All 4-Member Packs purchased during the term of a group subscription to the Service will share the same expiration date, regardless of when, during the term of the group subscription to the Service, the 4-Member Pack(s) are purchased.

Refundability of a 4-Member Pack

Rights granted to Covered members of the group are transferable as specified within the Group Subscription Agreement and Terms of Use. Therefore, the Purchase Price of 4-Member Pack(s) is not, in whole nor in part, refundable.

In the event of any inconsistency between this Purchase Agreement and the Group Subscription Agreement and Terms of Use, the provisions of the Group Subscription Agreement and Terms of Use will control.
